For over four and a half decades since its inception, Maharashtra has been the forerunner in contributing to India's economic development. Presently, Maharashtra accounts for 16 % of the Indian GDP. Mumbai is the commercial and financial centre of the country. With most financial institutions headquartered in Mumbai, the city has a great potential to develop into a financial hub of Asia.

The pro-active and growth oriented work culture of the State has always attracted national and international investors to the state and the pragmatic policies of the Government of Maharashtra have induced them to consider Maharashtra as the first choice for their investment and expansion plans. Not surprisingly, Maharashtra accounts for the largest chunk of domestic and foreign investments flowing into the country, for the last 15 years...

However, while, Maharashtra, because of its inherent strengths has the potential to play a pivotal role in achieving a sustainable annual growth rate of 10-12 %, it needs a Strategic Framework and a well-articulated Action-Plan to attain and sustain this objective, especially in the face of intensifying competition from other States.

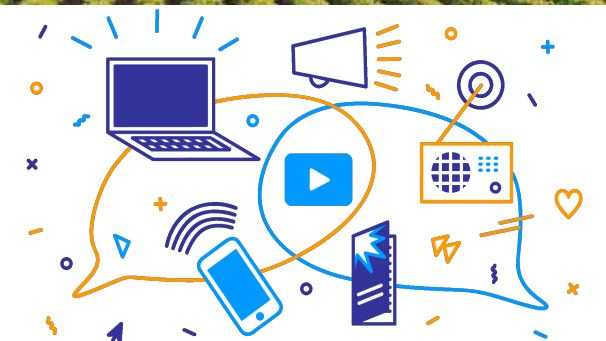
